5. Strategy to Reduce Phosporus Loss in the Thames River Basin

Charles Lalonde, Project Manager, gave a presentation on a joint OFA & Great Lakes & St Lawrence Cities Initiative Strategy to Reduce Phosporus Loss in the Thames River Basin. This initiative is part of the Great Lakes Water quality agreements. Nicola Crawhall, Project Lead for the Great Lakes & St Lawrence Cities Initiative, also attended. The ROMA Board members asked a number of questions and Chair Holman thanked Mr. Lalonde for his presentation.

6. ROMA Conference Update

Victoria Van Veen provided an update from the conference planning committee. The Committee is in the process of identifying conference topics and keynotes. She will be sending out a registration form, and asked the ROMA Board to provide their arrival and departure dates for the ROMA Board room block. Victoria will be working with Lorna to streamline AMO and ROMA Board requirements.

The conference theme will continue to be ROMA Speaks, with added messaging of ROMA Listens. Allan Thompson suggested having Patrick Moore (former head of Green Peace) as a keynote speaker on climate change, phosphorus and river health.
