#### **TIMED ITEMS**

7. The Honourable Kathryn McGarry, Minister of Natural Resources and Forestry

The Minister answered questions from the ROMA board on the aggregate resources study, recent species-at-risks announcements and on the Province's no net-loss approach to wetlands. On aggregate fees, Minister McGarry communicated that the study is complex and that there have been numerous holds up resulting in an indefinite delay in the report's release. Turning to species-at-risk, the Minister communicated that the measures were necessary and explained the process by which the endangered list is created. On wetlands, the Minister indicated that she is in the process of considering how to mitigate factors in the North.

8. The Honourable Bob Chiarelli, Minister of Infrastructure

The Minister answered questions from the ROMA board on sprinklers, broadband connectivity, asset management and on natural gas expansion. On sprinklers, Minister Chiarelli indicated that a small fund has been created to help LTC homes install sprinklers and that program details will be released shortly. On broadband expansion, the Minister indicated that connectivity should be viewed as an essential service and that the Ministry is considering measures to require utilities to map out where currently-unused broadband fibre has been installed so that the Province has a better idea of the infrastructure in place. Turing to asset management concerns, Minister Chiarelli indicated that financial supports for smaller municipalities are under consideration. The Ministry is also considering establishing a 'swat' team of engineers and expanding OSEF funding. Discussing natural gas expansion, Minister Chiarelli commented that the Province is looking for support from the Feds to move on that file.

Parliamentary Assistant Lou Rinaldi, Ministry of Municipal Affairs, also briefly joined the meeting and discussed changes to the Election Act requiring that candidates in municipal elections obtain 25 signatures. PA Rinaldi explained that this measure was established to deter insincere candidates. However, due to potential challenges this may present to smaller jurisdictions, the Ministry is considering making an exemption for certain municipalities based on size. Currently, the ministry is determining at what population count a municipality will be exempt. The board also expressed concern over the removal of LTC beds from rural regions.

Parliamentary Assistant Grant Crack, Ministry of Agriculture, Food and Rural Affairs, was unable to participate in the Board meeting due to time constraints.

## **POLICY ITEMS**

# 9. Policy Update

Cathie Brown updated the Board on the following policy issues. Bill 148, *Changing Workplaces Review, 2017* will have impacts on municipalities as employers. In particular, certain scheduling provisions and pay requirements for of seasonal workers may have a significant impact on municipal operations.

Bill 139, *Building Better Communities and Conserving Watersheds Act*, 2017 treats municipal decisions as mature. Municipal governments will need to work with the province to ensure a mutual understanding of the PPS at the outset of a planning amendment.

Bill 142, *The Construction Lien Amendment Act,* will change how contracts and procurements are done at the municipal level. Of concern are changes to timelines that will negatively impact municipalities ability to conduct proper due diligence measures before payment is promoted.

The Ontario Federation of Cottagers Association was seeking membership support from ROMA. By consensus this was declined.
