3. 9:30 – 9:50 a.m. Peter Maddox, Director, Government Regulations, Canadian Propane Association

Mr. Peter Maddox spoke to the advantages of propane as a fuel source. These include that it is less costly than electricity or oil, that it requires less infrastructure than natural gas and insurance rates are lower than fireplace and oil. The Canadian Propane Association is requesting ROMA's support for its proposal to start a conservation program similar to that of natural gas.

7. Waste Free Ontario Update

Amber Crawford provided an update on how this legislation is being implemented. Of note is the shift to producer responsibility that means blue box programs will be paid 100% by producers. The transition may be complex and municipal governments should not extend contracts until there is greater certainty around transition questions. This is also an opportunity for municipal governments to decide what role they may wish to take in recycling.

Also significant is the ban on organics in landfill. The EBR posting on this is expected soon.

Craig Reid provided an update on the Low Carbon Task Force and recent GHG Challenge Fund opportunities for municipal governments to participate. He discussed the proposed EV pilot project and ways to participate in cap and trade funding.
